

#### Aim of Activity \*

Access Enablers are activities that will support service delivery, including service navigation, NDIS testing support, capacity and strengths-based assessment, regional loading and PHN operational activity

Access Enablers will broadly aim to improve integration of local health services, promote multi-disciplinary care, and make the health system more accessible to people with severe mental illness and associated psychosocial disorders.

Access Enablers will continue to strengthen the capacity of consumers to live independently, safely and productively in their community and form meaningful connections in a supportive environment.

**Description of Activity \*** 

NBMPHN will continue to engage a commissioned service provider to deliver the Commonwealth Psychosocial Support service, inclusive of access enablers and service delivery components through a range of non-clinical supports at a group or and or individual level. The services may include:

• increasing understanding of the service options available across a range of service domains

• increasing choice in accessing a broader range of relevant health and support services to achieve recovery goals and manage conditions day to day in the community

• supporting access and engagement with dedicated and specialised support services to meet social needs, particularly access to safe and appropriate housing

• increasing understanding for GPs , program managers and service providers of services available to support the social, mental and physical health needs of with severe mental illness and promote effective multi-disciplinary care

• collaboration between PHN and LHD to develop joint understanding of psychosocial consumer referral pathways, available supports, service gaps and emerging issues

• access to the supports needed to promote mental and physical health; and

• assisting with accessing stable, safe and appropriate housing, given the strong link between stable housing and positive mental health outcomes.

Access enablers will also support PHN operational activity related to the delivery of this activity.



#### Aim of Activity \*

The aim of this activity is to commission the CPS Service Delivery to support people with severe mental illness and associated psychosocial functional impairment who are not accessing similar supports through the National Disability Insurance Scheme (NDIS) or state and territory based programs.

This will be achieved by:

• Facilitation of care coordination and non-clinical and clinical activities to enable the appropriate delivery of psychosocial support services in the community setting to support needs. These may be episodic and occur across several domains, including help with physical and mental health, employment, substance use, social isolation, family violence, access to appropriate housing, and navigating the justice system.

#### **Description of Activity \***

The activity will be conducted by the CPS commissioned service provider to ensure complementary and flexible services are delivered to support consumers experiencing severe mental illness by:

- increasing functional capacity to live independently in the community
- reducing the need for acute mental health services
- increasing connection and reduce isolation
- increasing knowledge and skills
- increasing engagement in daily activities, relationships and the community

- improving or stabilising mental health and wellbeing
- improving self-confidence and independence
- moving towards personal recovery goals and
- supporting access to appropriate supports, including the NDIS where appropriate
- access to brokerage funding where available to support consumer recovery needs.
