EFFECTIVE 1 APRIL 2019:

NEW MBS Items to fund Heart Health Assessments:

From 1 April 2019, two new item numbers will be available for Heart Health Assessments to support patients with cardiovascular disease, or patients at risk of developing cardiovascular disease. These items will fund a heart health assessment, lasting at least 20 minutes, by a general practitioner (Item 699) or a medical practitioner working in general practice (Item 177). **Full details of these and other changes can be found [here](#) at MBS Online.**

EFFECTIVE 1 MARCH 2019:

NEW MBS items for the provision of professional services by a doctor at a Residential Aged Care Facility (RACF):

From 1 March 2019, new Medicare rebates will be available for the provision of professional services by a general practitioner (GP) or medical practitioner at a RACF. This includes a one off single call-out fee and new standard Level A to D MBS attendance items. 12 RACF derived fee items will be obsolete, replaced with 12 new items.
